WHEREAS construction works have not commenced for many years on urban lands that were granted, in various ways, prior to the enactment of the Urban Lands Lease Holding Proclamation No. 80/1993;

WHEREAS some of the lands are found not to have been granted in line with master plans of towns; on the other hand it is proved that the capitals allotted do not cover the cost of construction works;

WHEREAS it has also been found out that some lands were granted permanently to projects that do not deserve to be so in the urban areas;

WHEREAS it has been deemed necessary to efficiently employ urban lands to projects or works that would best serve the populace;

2. Where an urban land is lawfully held but unutilised until construction works were suspended in April 1993:

a) it shall be reclaimed by the government where no construction is commenced within the time specified by law or a directive;

b) where the time specified by law or directive has not elapsed, the land shall be reclaimed by the Government and the expenses incurred to claim the land, to pay taxes and other administrative fees shall be repaid to the holder.

3. Where an urban land is reclaimed by the Government in accordance with sub-Article (2) of this Article, the holder shall remove the construction materials or the unauthorized construction works on the land within two months from the date of notification of the reclaimer failing which the city council may, within a short period of time, remove the materials and claim its expenses or sell the materials by auction to cover the same.

5. Size of Urban Land Holding

1. The size of an urban land to be granted shall be subject to the type of the project and the amount of capital to be allocated to it.

2. The Bureau may issue directives, which shall not be incompatible with a master plan of a town, on the size of urban lands to be awarded.

6. Period of Completion of Construction Work

1. Depending on the type and volume of the project, construction works in towns shall be completed within the maximum period specified in the table herein from the date of issuance of the work permit;

2. Constructions on which foundation works have been completed before the issuance of these Regulation shall receive a written notification on the period of time within which to complete the remaining works on the basis of evaluations to be made by experts.

3. The time of completion to be granted under sub-Article (2) of this Article shall not exceed one year.

4. Where construction work is not completed within the period specified under sub-Article (1) or (2) of this Article, the property on the land shall be sold by auction, ten per cent (10%) of the proceeds shall be retained by the city council by way of penalty and the balance shall be paid to the holder.

7. Temporary Granting of Urban Lands

1. Urban land may be granted on a temporary basis by way of contracts (lease) to the following services or projects:

- a) agricultural and planting of trees;
- b) livestock rearing;
- c) animals fattening;
- d) garage works;
- e) storage and retail of construction materials (sand, iron bars, wood, pipes, blocks, bricks and the like);
- f) blocks and pipes production cites;
- g) quarries where stones, sand, pebbles and similar other mine are extacted;
- h) retail shops or storage facilities carried out in mobile houses or containers;
- i) parking lots.

The rent on lands temporarily granted shall be determined by the city council per square meter per annum on the basis of the land grade and the demand but shall not be less than the rate of rent of the land; provided however, that where several persons request a plot of land, the grant shall be determined by tender.

Where the land specified under sub-Article (1) of this Article, has been held lawfully before the enactment of the Proclamation:

 - a) the holder shall return his certificate of possession and, unless an appropriate authority decides otherwise, conclude a temporary land holding contract which shall not last more than three years;
 - b) the rate of rent shall be the annual rent payable on the land;
 - c) the concerned city council may extend the duration of the contract and determine the rent payable unless an appropriate body decides otherwise.

Where appropriate, a temporary contract for granting urban land may be renewed every year.

Where a temporarily granted urban land is required for another purpose, a city council may at any time terminate the contract upon giving a three months notice to the holder.

6. Penalty

1. Whosoever obstructs the implementation of the provisions of these Regulations or directives to be issued in accordance with these Regulations shall be punishable under the law.

2. Whosoever carries out construction works, without obtaining the required permit from the appropriate body, after the issuance of these Regulations shall waive his right over the property on the land to the city council.

9. *Powers to Issue Directives*

1. The Executive Committee may issue directives for the implementation of these Regulations.
2. Where necessary, the Executive Committee may delegate its powers in whole or part to the Bureau.

10. *Inapplicable Regulations*

Any regulations, decision or directive which is inconsistent with these Regulations shall not apply with respect to matters provide for in these Regulations.

11. *Effective Date*

These Regulations shall enter into Force as of October, 1995.
