#### REGULATIONS NO.12/1998

#### REGULATIONS TO PROVIDE FOR ADVOCATES INCOME TAX

These Regulations are issued by the Executive Committee of the Oromia Regional State pursuant to Article 54(6) of the Constitution of the Region.

#### 1. Short Title

These Regulations may be cited as the "Advocates Income tax Regulations No. 12/1998".

#### 2. Income Tax

1. Any advocate permitted to work in the Oromia Region by the concerned executive organ shall pay income tax as follows:

- (a) Abukaattoni sadarkaa tokkoffaa wagga-wagg-adhaan qarshii 340 (dhibba sadiif afurtama);
- (b) Abukaattoni sadarkaa lamaffaa wagga-wagg-aadhaan qarshii 178 (dhibba tokko fi torbaat-amii saddeti).
2. Akkaataa labsii Taaksii gurguraa fi Eksaayizii lakk.68/1985 (akka fooyya-etti) abukaattoni taaksii gurguraa ni kafalu.
3. Aangoo Qajeelfama Baasuu  
Biiroon Faaynaansii Oromiyaa Dambii kana hojiirra oolchuuuf qajeelfama barbaachisaa ta'e baasuuuf aangoo ni qabaata.
4. Tumaatoota ce'umsaa  
Dambiin kun otoo hin ragga'in dura gibirri galii abukkattoota irraa barbaadamu haala seeroottaaaf qajeelfamoota armaan dura turaniin murtaayee ni sasabama.
5. Yeroo Dambii Kun itti ragga'u

- a) First grade advocate... Birr 340.00 (three hundred fourty Birr).  
b) Second grade advocate... Birr 178.00 (one hundred seventy eight Birr).
2. Any advocate shall pay service tax in accordance with the Sales and Excise Tax Proclamation No. 68/1993 (as amended).
3. Power to issue directives  
The Oromia Finance Bureau shall have the power to issue directives for the proper implementation of these Regulations.
4. Transitory provisions  
Income taxes due prior to the coming into force of these Regulations shall be paid in accordance with the relevant tax laws and directives in force.
5. Effective date  
These Regulations shall enter into force as of 7th day of August 1998.
