OROMIA COOPERATIVE
BANK ESTABLISHMENT
REGULATION

- Short Title**
 These regulations may be cited as "the Oromia Cooperative Bank Establishment Regulation No. 26/2002".
- Issuing**
 These Regulations are issued by the Regional Administrative Council of Oromia pursuant to Articles 55(6) of the constitution of the Oromia Regional State.
- Establishment**
 There is here by established the Oromia cooperative Bank Project Office (here in after the office) by these Regulations.

8. *Aangoo fi hojii Hojii adeemsisaa Ol'aanaa*
 Hojii adeemsisaan ol'aanaa dambii kana keewwata 7 jalatti Waajjirichaa aangoo fi hojii kenname raawwatu irratti dabalatee hojii kanatti aanu ni raawwata.
- 1) Dambii kanaa fi Waajjira Ol'aanaa Gamtaawina ummataatiin qajeelfama kennamuuf hordofuudhaan hojii waajjirichaa fi bulchiinsaa gaggeessuuf itti gaafatamaa ta'a.
 - 2) Waajjiricha ni gurmessa, hojjatoota ni qaxara, ni bulcha.
 - 3) Maallaqa Waajjirichaa Baankiitti ni galcha, mallattoo isaatiin ni sochoosa.
 - 4) Maqaa Waajjirichjaatiin waliigaltee ni seena.
 - 5) Waajjiricha bakka bu'ee ni himata, ni himatama yookiin abukaatoodhaan dhimmi waajjirichaa akka hordofamu nitaasisa.
 - 6) Hojii Waajjirichaa raawwachiisuuf aangoo isaa irraa qoodee itti gaafatoota waajjirichaatiif bakka bu'ummaadhaan ni kenna.

11. Yeroo Dambiin Kun itti ragga'u
 Dambiin kun Caamsaa 29 bara 1994 irra kaasee kan ragga'u ta'a.

፪. ፅሕፈት ቤቱን፣ የደራጃል፣ ሠራተኞች፣ ይቀጥራል፣ ያስተዳድራል።

፫. የፅሕፈት ቤቱን የባንክ ሂሳብ ይከፍታል፣ በፊርማው ያንቀሳቅሳል።

፬. በፅሕፈት ቤቱ ስም ይዋዋላል።

፭. በፅሕፈት ቤቱ ስም ይከሰሳል፣ ወይም ጉዳዩን በነገረፈጅ ይከታተላል።

፮. የፅሕፈት ቤቱን ተግባር ለማስፈጸም ከስልጣኑ ከፍሎ ለድርጅቱ ኃላፊዎች ውክልና ይሰጣል።

፻) የጽሕፈት ቤቱ በጀት

ጽሕፈት ቤቱ የሚያስፈልገውን በጀት ለክልሉ መስተዳድር ምክር ቤት አቅርቦ ያስፈቅዳል።

፲) ጽሕፈት ቤቱ የሚቆይበት ጊዜ

ጽሕፈት ቤቱ የእርምጃ ሕብረት ሥራ ባንክ ሕጋዊ የባንክ ሥራ ፈቃድ ሲያገኝ ይፈረሳል።

፲፩) ደንቡ የሚፀናበት ጊዜ

ይህ ደንብ ከግንቦት ፳፱ ቀን ፲፱፻፺፬ ዓ.ም. ጀምሮ የፀና ይሆናል።

8. Powers and Duties of the General Manager

The General Manager, along with implementing functions of the office enumerated under Article 7 here of, shall have the following powers and duties.

- 1). Without limiting the generality of directions giving to the General Manager in this regulations and by the Supreme office of Mass Organizational Affairs of Oromia, he shall be responsible to direct the operation and administration of the office.
- 2). Organize the office, employ or terminate employment contracts.
- 3) Open and operate Bank accounts in the name of the office.
- 4) Enter into contract on behalf of the office and;
- 5) Sue or be used on behalf of the office or handle the suit through attorney.
- 6) Delegate his authority to officers of the office .

9. Budget

The office shall submit to the Regional Council for approval, the budget it requires for its operations.

10. Duration of the Office

The office shall be abolished when the Cooperative Bank of Oromia obtains its legal license to carry out Banking Operations.

11. Effective Date

These Regulations shall come into force as of the 6th day of June 2002.
