Regulation for the Establishment of Oromia Environmental Protection office.

WHEREAS, environmental pollution, disturbance of ecological balance and environmental degradation in Oromia is fund at an alarming stage.

WHEREAS, it has become necessary to establish a body responsible for the protection of nature and environment to be bequeathed to the future generation and monitoring of the proper implementation of Government policies and laws on environment.

NOW, THEREFORE, in accordance with Art. 55 (6) of the constitution of Oromia Regional National State, it is hereby proclaimed as follows:

1. *Short title*
 This Regulation may be cited as the 'Regulation for the establishment of Oromia Environmental Protection Office No. 28/2002'.

5) Undertake environmental Auditing on the manner of liquid and toxic wastes disposal and toxic wastes disposal management by factories and industries, so that it may not damage the environment. Without prejudice to the authority given to the other organs, under other laws owing to their specific nature, Regulate & supervise waste disposals from different industries and urban pollutants, and the ecosystem, and take corrective measures if so happened.

6) Based on the objective situation of the Region, prepare Environmental standards; and regulates its implementation by the respective bodies.

8) Collect, organize and analyse environmental economic data, and make use it or avails it for use.

9) Promote public and concerned organs awareness on the environmental issues.

Organization

The office shall have the following organization:

a) The Head appointed by the President of the Regional Government and approved by the Council of the Region.

b) Other necessary staff.

8. **Power and duties of the Head of the Office**

In addition to implementation of the power and duties of the office stated under Article (6) of this Regulation, the head of the office shall have the following power and duties:

a) organize the office with manpower and material.

b) study and present the organizational structure, budget and work plan of the office to the respective organ and implementation upon approval.

c) employ and administer employees in accordance with civil service laws.

d) direct, administer and represent the office; deal and perform agreements with third parties.

e) regulate and follow up various sections of the office that they are properly performing their duties and responsibilities.

f) prepare and submit the performance and financial report of the office.

7. **Gurmaawina**

(a) Waajjiricha humna namaa fi meeshaadhaan ni gurmessa;

(b) Casaa, baajataa fi Karoora hojii waajjirichaaf barbaachisu goratee gaama ilaaltu ni dhyaessa; ennaa hayyamames hojii ni oolcha;

(c) Akkaataa seera hojjetoota mootummaatiin hojjetoota ni qaxara, ni bulcha;

(d) Waajjiricha ni hooggana, baakka bu'ees gaama biroo wajjin walitti dhufeenya hojii gochuudhaan waliigalee ni raawwata.

(e) Kulaleen adda adda waajjiricha dirgamaa fi ittiigaatama isaanif kenname haalaan bahu isaanii ni hor-dota, ni ta'ata;

(f) Gabasa raawii hojii fi herrega waajjiricha gophessee ni dhiyessa.

- (g) Akkuma barbaachisummaa isaatti aangoo seeraan kennameef irraa bakka bu'ummaan kennuu ni danda'a. Bakka bu'iinsichi yeroo ji'a tokko caaluuf yoo ta'e Pirezidaantii Bulchiinsa Mootummaa Naannichaatti beeksisuu qaba.
- (h) Hojiilee biroo seeraan kennamaniif ni raawwata.

- g) where necessary, may delegate his legal authority. If the delegation exceeds a period of one month, the President of the Regional Government shall have to be duly notified.
- h) Perform other activities entrusted on him by law.

9. Budget

The budget of the office shall be drawn from:-

- 1) budgetary allocations by the Regional Government
- 2) aid and any other sources.

10. Book accounts and Financial Documents

- 1) The office shall have complete and accurate books accounts.
- 2) The accounts and financial documents of the Office shall be audited annually by the Auditor General of the Region or by auditors designated by him.

11. Effective Date of the Regulation

This Regulation shall enter into force as of the 26th day of June 2002.
