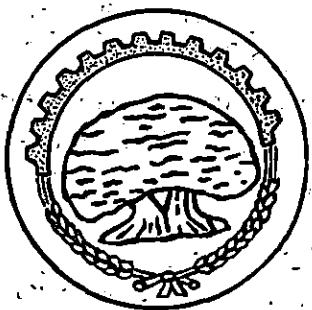

Regulations No. 7/1997
 Regulations to provide for the Establishment of Finfine Forestry Development and Marketing Enterprise

1. **Short Title**
 These Regulations may be cited as the "Finfinne Forest Development and Marketing Enterprise Establishment Regulations No. 7/1997".

2. **Issuing Authority**
 These Regulations are issued by the Executive Committee of the Oromia Regional State pursuant to Article 54(6) of the Constitution of Oromia Regional State and Oromia Regional State Enterprise Proclamation No. 16/1997.

3. **Establishment**
 1. There is hereby established the Finfine Forestry Development and Marketing Enterprise (hereinafter the "Enterprise") as a public enterprise.

- 2. Dhaabbatichi akkaataa Labsii Dhaabbatoota Misooma Mootumma Naannoo Oromiyaa Lakk. 16/1989 tiin bula.
- 4. **To'ataa Abbaa Taayitaa**
Koree Hojii Raawwachiiftuun Mootummaa Naannoo Oromiyaa ykn qaamni korichi kun moggaasu To'ataa Abbaa Taayitaa Dhaabbatichaa ta'a.
- 5. **Teessoo waajjira ol'aanaa**
Teessoon waajjira ol'aanaa Dhaabbatichaa Finfinnee ta'ee akka barbaachisaa ta'etti iddoo kamittiyyuu damee waajjiira isaa qabaachuu ni danda'a.
- 6. **Kaayyoo**
Kaayyoon Dhaabbatichi itti hundeeffame kan armaan gadii ta'a
 - a) haala walirraa hincinneen muka ijaarsaa, utubaa eleektriikaa, muka qoraanii, callaa bosonaa kan biroo gabaaf dhiyeessuu;
 - b) callaa bosonaa kan offi fi bittaaadhaan kan argaturraa xaawulaa, "chipboard", cilee, fi callaa kan biroo omishee gabaaf dhiyeessuu;
 - c) iddoo konseeshiniin keenna-meefirratti hojii Eko-turizimii gaggeessuu;
 - d) bosona keewwata 7 keewwata xiqqaa (1) irratti ibsame haala Labsii Eegumsaa, Misoomaa fi Ittifayyadama bosonaa Lakk. 94/1986 akkasumas Dambii fi Qajeelfama dhimmi ilaaluu ni eega, ni misoomsa;
 - e) akka barbaachisaa ta'etti jireenya ummataa Naannoo lafa konseeshinii fi lafa konseeshinii keessa jiraatuu foyyeessuuf misooma baadiyyaa gaggeefamurratti hirmaachuu;
 - f) kaayyoo isaa bakkaan ga'uuf kan gargaaran hojii daldalaa walfakaatu gaggeessuu.
- 7. **Iddoo konseeshinii**
 - 1. Iddoon konseeshinii ykn lafti kennameef heektaara 24075 (kuma digdamii afurii fi torbaatamii shan) ta'ee;
 - a) Heektaarii 21810 (kuma digdamii tokkooo fi dhibba sadd-eetii fi kudhan) bosona omishni itti gaggeeffamu (Bosona harkaan dhaabbame) fi

- ፪. ድርጅቱ በአርሚያ የመንግሥት የልማት ድርጅቶች አዋጅ ቁጥር 17/1997 ፻፹፱ መሠረት ይተዳደራል።
- ፫. **ተቆጣጣሪ ባለሥልጣን**
በአርሚያ ከልላዊ መንግሥት ሥራ አስፈጻሚ ኮሚቴ ወይም ኮሚቴው የሚሰይሙ ሰው አካል የድርጅቱ ተቆጣጣሪ ባለሥልጣን ይሆናል።
- ፬. **ዋና መሥሪያ ቤት**
የድርጅቱ ዋና መሥሪያ ቤት ፊንፊኔ ሆኖ እንደ አስፈላጊነቱም በማናቸውም ሥፍራ ቅርንጫፍ ጽ/ቤት ሊኖረው ይችላል።
- ፭. **ዓላማዎች**
ድርጅቱ የተቋቋመባቸው ዓላማዎች የሚከተሉት ናቸው፡-
 - ሀ) ዘላቂነት ባለው መልኩ የኮንስትራክሽን እንጨት፣ የኤሌክትሪክ ምሰሶ፣ የማገዶ እንጨትና ሌሎችንም የደንውጤቶች ለገበያ የማቅረብ፣
 - ለ) ከራሱ እና በግዥ ከሚያገኘው ጥሪ ዕቃ ጅግ ወደግ ጣውላ፣ ከለል እና ሌሎችንም ምርቶች ለገበያ የማቅረብ፣
 - ሐ) በኮንሴሽን በተሰጠው ቦታ የኢኮኖሚክ ሥራዎችን የማካሄድ፣
 - መ) በአንቀጽ 7 የተጠቀሰውን የደንብ በደን ልማት ጥበቃና አጠቃቀም አዋጅ ቁጥር 17/1997 ፻፹፱፣ አግባብ ባላቸው ሌሎች ሕጎችና ደንቦች መሠረት የመንከባከብና የማልማት፣
 - ሠ) እንደአስፈላጊነቱ በድርጅቱ ክልል ውስጥና አካባቢ የሚኖሩ ሰዎችን የኑሮ ደረጃ ለማሻሻል በሚካሄደው የገጠር ልማት የመሳተፍ፣
 - ረ) ዓላማውን ከግብ ለማድረስ የሚረዱ ሌሎች ተዘማጅ የሆኑ የንግድ ሥራዎችን የማካሄድ።
- ፮. **የኮንሴሽን ቦታ**
 - ፩. ጠቅላላ የኮንሴሽን ቦታ ስፋት 24075 (ሃያ አራት ሺህ ሰባ አምስት) ሂክታር ሆኖ፡-
 - ሀ) ፳፩ ሺ ፻፶፯ (ሃያ አንድ ሺህ ስምንት መቶ አሥር) ሂክታር ዋና የማምረቻ ደንብ (ሰው ተከል ደንብ) እና፡

- 2. The Enterprise shall be governed by the Oromia Regional State Enterprise Proclamation No. 16/1997.
- 4. **Supervising Authority**
The Executive Committee of the Oromia Regional State or a body to be designated by the Committee shall be the supervising authority of the Enterprise.
- 5. **Head Office**
The Enterprise shall have its head office in Finfinne and may have branch offices elsewhere as may be needed.
- 6. **Purposes**
The purposes for which the Enterprise is established are:
 - a) to sustainably produce logs, construction and transmission poles, fuel wood and other forest products for sale;
 - b) to manufacture from own and external resources lumber, Chipboard, charcoal, and other products for sale;
 - c) to undertake eco-tourism activities in the Concession area;
 - d) to Conserve and Develop the forest resource described under Sub-Article (1) of Article 7 in accordance with the Forestry Conservation, Development and Utilization Proclamation No. 94/1994 and other relevant regulations and directives;
 - e) to take part in community development of the rural area with in and around the Enterprise boundary, if necessary;
 - f) to engage in any other related business activities as necessary for the attainment of its purposes.
- 7. **Concession area**
 - 1. The total Concession area is 24,075 (Twenty Four Thousand and Seventy five) hectares of which:
 - a) 21,810 hectares classified as Primary production Forest (plantation forest) and

b) Heektaarii 2265 (kuma lamaa fi dhibba lamaa fi jaatamii shan) bosona uumamaa kan midhame jedhamee hirameera.

8. Kaappitaala

Kaappitaalli Dhaabbatichaaf eeyyamame Qarshii 121,017,297.00 (Miliyoona dhibba takkoo fi miliyoona digdamii tokkoo fi kuma kudha torbaa fi dhibba lamaa fi sagaltamii torba qofa) yammuu ta'u hundi isaa qarshii fi gosaan kaffalam-eera.

2. The boundaries of the concession area stated in sub-article (1) of this Article shall be defined by the map of the concession area which shall be approved by the Executive Committee of the Oromia Regional State.

8. Capital

The authorised capital of the Enterprise is Birr 121,017,297.00 (One Hundred Twenty one million and Seventeen Thousand and Two Hundred Ninety Seven Birr Only) which has been fully paid up in cash and in kind.

9. Liabilities

The Enterprise shall not be liable beyond its total assets.

10. Duration

The Enterprise is established for an indefinite duration.

11. Effective Date

These Regulations shall enter into force on the date of their publication in Megeleta Oromia.
